

If your contract is inside IR35, you will lose the ability to pay yourself tax-efficiently through a combination of low salary and high dividends because the income received from the contract will be classed as 'deemed employment income', subject to Tax and National Insurance Contributions (NICs)

HMRC reveals a drop in buy-to-let tax disclosures

The tax yield from the Let Property Campaign, which launched in 2013, dropped almost 50% from around £34m in 2019-20 to around £17m in 2020-21, This was the lowest figure recorded in seven years.

Landlords with undeclared property income can use the 'Let Property Campaign' to disclose their rental income to HMRC and bring their tax affairs in order with the best possible terms.

30 November 2020.

01 August 2021	 Corporation tax payment due for year ended 31 October 2020, for those companies not liable to pay their liability by instalments.
02 August 2021	• Filing date for form P46(Car) for quarter ended 5 July 2021.
05 August 2021	 Quarterly report by employment intermediaries for period 6 April to 5 July 2021.
07 August 2021	• VAT return - Due date for 30 June 2021 VAT returns, unless exempted.
21 August 2021	 Intrastat - Due date for payment of supplementary declarations for July 2021.
22 August 2021	 Monthly electronic PAYE/class 1 NICs/student loan payment - If paying electronically, pay PAYE, class 1 NICs, student loan deductions and deductions from payments to subcontractors for July.
31 August 2021	Company accounts filing deadline - Deadline for filing of company accounts with the company house for the accounting period ending
